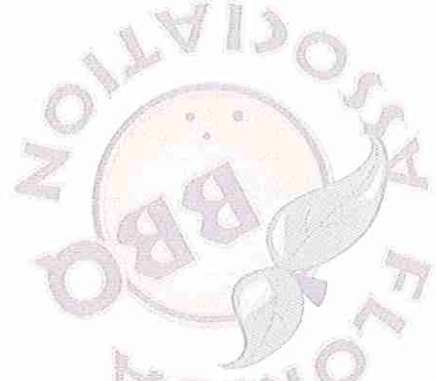

RULES & REGULATIONS

1. Arrival/Set-up begins Thursday, April 24, 2014 at 12:00 noon and Friday 4/25/14 at 8:00am.
2. Cook sites are 20' x 40' and will be assigned upon arrival. One (1) space per team. If you would like adjoining sites with friends you must arrive together.
3. Entry fees must be received no later than 4/18/14. Entry Fee (non-refundable) must accompany the registration form.
4. Ice will be available for purchase on-site.
5. Beer and wine will be sold on-site.
6. Meat inspection begins at 12:00 noon Friday, April 25, 2014.
7. A mandatory cook team meeting will be held on Friday, April 25, 2014 at 5:00pm.
8. Water and electricity (2-110 circuits/20 amps) will be provided. Bringing a generator is advised.
9. A quiet time is in effect from 11:00pm of the night prior to judging until 6:00am the following morning. Failure to observe this quiet time may subject the offender(s) to removal from the contest site.
10. Pets are not allowed.
11. Trash will be removed periodically by staff.
12. Ash and grease disposal drums will be on site.
13. No ancillary sales are permitted without the express approval of the event committee.

There will be Live Entertainment, Cornhole Tournaments and other activities during the event.

Vending will begin Friday 4:00pm-10:00pm and continue throughout the day on Saturday 10:00am-10:00pm.
